

First, thank you for your support of Yampa Valley Sustainability Council (YVSC) in 2020. Your investment in our mission and work on the ground enabled us to continue building momentum across our programs, partnerships and education at a time of upheaval, distance and uncertainty.

2020 was an unprecedented year in the Yampa Valley, nationally and globally.

We entered the worst global pandemic since 1918, and the effects of COVID-19 have been pervasive, uneven and enduring. Our global economy was the weakest it has been since the Great Depression, and our local economy was fiercely tested. Across the nation, structural and interpersonal racism, class divides, political partisanship and inequity have been laid bare and challenged. We experienced the worst trends in global warming in our recorded history.

As an integrated environmental conservation and sustainability-focused organization in Routt and Moffat County, it is in our mission to identify how to best address the most pressing sustainability issues of our time in relation to our community's needs and conditions. As COVID-19 redefined our systems, we



became nimble and active and learned what Collaboration, Equity, Community, Climate Change and Resilience ought to mean moving forward. We share our reflections on these concepts throughout this report.

It is noteworthy that through the year's challenges, our community showed resilience and adaptive capacity. Community members, businesses, first responders, and local government worked tirelessly and did what it takes to keep a community like ours safe, informed, and prepared. Reciprocally, the community became practiced at facing uncertainty, identifying knowledge gaps, learning, monitoring and adjusting behaviors as needed for the well-being of others.

During such an unprecedented year, we at YVSC also underwent transition. I joined YVSC as our Executive Director in February 2020 – following Sarah Jones' foundational steerage from 2011 – 2019 – just before our Stay at Home orders took effect. My learning curve at YVSC was shaped by the urgency to advance climate action when so many forces were pushing it to the backburner. As businesses and schools closed and social services were strained, the effects of climate change escalated: August 2020 was the hottest, driest month in western Colorado's recorded history and autumn was defined by the three largest wildfires in Colorado's history.

As an organization we streamlined our operations

and made the strategic decision to develop a climate action program that advances both decarbonization and natural climate solutions. Decarbonization means transitioning towards low-carbon energy, transportation and waste systems. Natural climate solutions are investments in land and water conservation and restoration that can help reduce emission and build resilience to the impacts of climate change. With this two-pronged climate action agenda at our core, we began scoping our programs and path forward accordingly.

As we move forward in 2021, we are working to build our capacity and increase our technical expertise across five Priority Areas: Resilient Land and Water; Waste; Energy; Transportation; and Community Education and Engagement. These Priority Areas are united by their potential to reduce emissions and build resilience through programs, partnerships and education. Our approach is collaborative, systemsoriented and science-based and our goal is to make climate action something that capitalizes upon and safeguards the people and places of the Yampa Valley we cherish.

We look forward to partnering with you in the year ahead.



New to YVSC is our Natural Climate Solutions (NCS) Program. By naming NCS a priority area we are investing in land and water conservation and restoration practices that can help reduce greenhouse gases and build resilience to the impacts of climate change. In the development of this program, we have established the underlying principals that will shape this priority area for Tim Sullivan, our new NCS Program Director, to adopt and build off.

This year we continued our work on the Yampa River Forest Restoration Project (YRFRP). Notably, we hosted our celebrated, community event, Retree, where 68 volunteers helped us plant narrowleaf cottonwood trees along the Yampa River.

Rural areas, such as the Yampa Valley, often face limitations in waste diversion opportunities if there is a shortfall in access to infrastructure to support diverting practices. YVSC continued to offer solutions to close this gap by supporting the diversion of organic waste through a partnership with Innovative Regeneration Colorado (IRC). In 2020, IRC diverted 40.42 tons of pre-consumer food waste to pigs and composted 5.658 tons of post consumer food waste. Additionally, YVSC safely hosted our annual Fall Recycling Drop-Off event for hard to recycle materials.

In 2020, clean became the new green. Early on during the pandemic there was a huge concern that shared surfaces, such as grocery bags, could serve as a potential vector for transmission of the COVID-19 virus. Research evidence suggested that transmission was no more likely through paper versus plastic bags. With this support, YVSC suggested that the city maintain the plastic bag ban and wave the fee for paper bags. This suggestion was adopted, prioritizing the health and safety of our community without compromising our citywide position against single-use plastic bags.

2.1 RESILIENT LAND & WATER

Natural Climate Solutions

Natural Climate Solutions (NCS) are land management practices - conservation, restoration, and improved management - in our grasslands, forests and wetlands that increase carbon storage and resilience and reduce GHG emissions. We cannot meet our climate change goals either here in the Yampa Valley or at the global stage without increasing our investments in conserving nature.





Actions

1. Yampa River Forest Restoration Project

YVSC launched the Yampa River Forest Restoration Program (YRFRP) in 2019 in response to the City's 2018 Yampa River Health Assessment and Streamflow Management Plan, which found that the riparian forest along the Yampa River is degraded on the reach above the Chuck Lewis State Wildlife Area and through town to the Wastewater Treatment Plant. Enhancing the quality of the vegetation, particularly the shading canopy cover, was identified as a top priority action in the plan to improve stream temperature and water quality on the Yampa River, over time. Reforestation will also help to restore aquatic and terrestrial habitat and stabilize the river channel, thus making it more resilient to floods, droughts and human impacts. One of the foundational projects that has played an integral role in the development of this program is the annual ReTree planting event that we have hosted over the past 11 years. 2020's ReTree planting event supported the second year of the sustainability council's YRFRP at the City of Steamboat Springs' Rotary Park.

2. ReTree

Despite the challenges introduced to hosting in-person events over the past year, YVSC was grateful to have been able to convene volunteers for our celebrated, annual community event, ReTree, while adhering to COVID-19 safety protocols. 68 volunteers joined together to plant 320 narrowleaf cottonwood, *Populus angustifolia*, along the Yampa River as a part of YRFRP.

3. Wildfire Mitigation & Education

Wildfires are one of the ways that we know climate change here in the Yampa Valley. In 2020 we saw the three largest wildfires in Colorado's history. We see Wildfire Mitigation and Education as an essential role in the resiliency of our local landscapes. For this reason, YVSC has played an active role in creating the Routt County Wildfire Mitigation Council (RCWMC). Through this partnership, YVSC helps connect Yampa Valley residents and tourists with information and action plans to promote fire-safe behaviors, mitigated landscapes and defensible space. In 2020, YVSC helped with the continued development and launch of the RCWMC while also mentoring a CSU Intern that supported the RCWMC. Additionally, YVSC partnered with the U.S. Forest Service to reseed an area of forest lost to the Silver Creek Fire in 2019. In this collaboration, YVSC helped gather volunteers to spread 40 pounds of lodgepole pine seed in the Sarvis Creek area. As fires continue to burn across the state, participating in this kind of post-fire forest regeneration work is a timely and impactful way to restore our area and increase resilience to continued drying in the future.



COMMUNITY ENGAGEMENT

Many of YVSC's events this year were centered around climate action, which included a presentation by Dr. Will Toor, Executive Director of the Colorado Energy Office on Colorado's Road Map to GHG Pollution Reduction. Through events like these we hope to bring the community into the dialogue of local climate change impacts and upcoming actions the community will be taking.

2.2 WASTE DIVERSION

Supporting the road to 45% materials diverted from the landfill

Colorado's current municipal waste diversion rate is only 15%, far below the national average of 35%. Rural areas, like Routt County, fall even further below the Colorado waste diversion rate, coming in around 12%. The new goal for Colorado is 45% recovery by 2036.

YVSC works with community members and partners to increase waste diversion and continue to scale successes through our implementation of the Waste Diversion Strategic Plan for Routt County.

Actions

1. New Opportunities for Organics

Through the work of the Organics Recycling Task Force, YVSC supported the launch of a local household composting option, which is administered and run by Innovative Regeneration Colorado. The IRC helped divert 40.42 tons of pre-consumer food waste to pigs and compost 5.66 tons of post-consumer food waste. The Task Force also organized a Pumpkins for Piggies event, which created an outlet for Halloween pumpkins to be used as animal feed or compost. This initiative diverted 1,996 pounds of pumpkins. YVSC also continues to oversee the use of three Earth Cubes within the community, which are in-vessel composting systems.

2. Promoting Reuse

Construction materials continue to be a top material going to landfills throughout Colorado, and the Yampa Valley is no exception. YVSC has created the Yampa Valley Construction Salvage Facebook page, which creates an opportunity for builders and community members to buy, sell, and give away construction materials that would otherwise be sent to the landfill.



3. Recycling Right

YVSC continued to promote the use of our Yampa Valley Recycles (YVR) app, the go-to source of information for all local recycling questions. We were also able to successfully and safely host our Fall Recycling Drop-Off amidst the COVID-19 pandemic with careful planning and consideration in order to ensure that recycling avenues were created for materials that cannot be recycled locally year-round.

COMMUNITY ENGAGEMENT

A key part of increasing the success of sustainable materials management is education. YVSC continues to support community confidence in recycling and decreases in contamination by serving as an information resource for community members. We produced the last edition of our print Recycling Guide, which aimed to increase more community-wide usage of the YVR app. We continue to post recycling tips in our monthly newsletter about frequently asked recycling questions, and we produced an educational video on the merits of composting. By working with our local haulers, YVSC creates a bridge of communication for recycling information and options.

2.3 ENERGY & TRANSPORTATION

Promoting Low-Carbon Energy & Transportation in Routt & Moffat Counties

The power sector and transportation are the two largest producers of greenhouse gas emissions in Routt County and statewide, making them leading priorities and opportunities for "green economy" planning and action. Investing in well-planned, inclusive clean energy infrastructure and technology has the potential to increase economic growth while reducing greenhouse gas emissions. YVSC continues to support the move towards low-carbon energy and transportation futures in the Yampa Valley.

Actions

1. Improving Commercial & Residential Energy Efficiency

YVSC continues to facilitate commercial and residential energy assessments to help owners identify affordable and effective ways to save energy and improve efficiency; partner with local government to ensure that building energy codes are up to date; and work with residents and business owners to increase capacity for EV and renewable energy adoption.

2. Advancing Safer & More Energy Efficient Homes – EPA Environmental Justice Small Grant

Through healthy homes evaluations, energy assessments, home safety and energy efficiency retrofits, and education and coaching, YVSC helped low-income families reduce health and safety hazards and increase energy efficiency. In alignment with necessary COVID-19 precautions, YVSC completed 8 of 10 target low-income household retrofits. With support of a US EPA Environmental Justice Small Grant (EPA EJSG), YVSC helped low-income households reduce health and safety hazards and increase energy efficiency through healthy homes evaluations, energy assessments, education and home safety and energy efficiency retrofits. With necessary COVID-19 precautions in place, YVSC completed 8 of 10 target low-income household retrofits in 2020.





YVSC shifted its annual Sustainable Building Tour to a virtual format. The two-part webinar series showcased two homes in Routt County that have taken important measures to improve energy efficiency and reduce environmental impact. The webinars included a video walk-through of each home and a Q&A session with the builders afterwards, which created a great opportunity for open dialogue surrounding the intricacies of green building in the valley.

4. Low-Carbon Transportation

YVSC held its annual CARbon-Free Challenge (formerly the Commuter Challenge), during which participants log their miles travelled using alternative transportation as an individual, adult team, or family. Each year, the Challenge serves as an important instrument for collective community-based action and education surrounding the impact of conventional transportation.

2.4 COMMUNITY EDUCATION & ENGAGEMENT



Community Education and Engagement are central to what we do at YVSC and why we do it.

YVSC works to bring our valued community members and partners together to define and address sustainability challenges and ensure that our goals and outcomes both capitalize on and serve our unique Yampa Valley communities and landscape.



Actions

1. YVSC Monthly Community Meetings

In 2020 our monthly Community Meetings shifted online. The virtual format significantly increased participation: the number of attendees in 2019 averaged 10-12 attendees and in 2020 our attendees ranged from 28-52 each meeting. Our Community Meetings convene community partners and community members to discuss topical issues and are structured to have a featured guest speaker followed by a prompt-led roundtable discussion. We also host quarterly Partner Update Community Meetings, where YVSC and community partner organizations/entities provide updates on their programs, events and volunteer opportunities.

2. Sustainability Speaker Series

The Talking Green event series looked a bit different this year as a result of gathering restrictions due to the COVID-19 pandemic. YVSC took this moment as a time to rethink and reshape how we approach this event series. We made the decision to rebrand the Talking Green Event Series into the Sustainability Speaker Series by formalizing a partnership between YVSC, Colorado Mountain College, and the Bud Werner Memorial Library to increase the reach of these events. Additionally, we shifted our monthly discussions to a quarterly event series to improve the quality of the events, bring in bigger speakers, and garner more participation. In 2020 we hosted two virtual events for the Sustainability Speaker Series.

Youth Involvement in Conservation Education & Reforestation

Sustainability is anchored in enabling the lives of future generations to thrive. Integrating youth into the conservation education and activities of today not only serves to protect their future but can also cultivate a lifelong affinity and connection to their environment. In 2020 YVSC hosted Rocky Mountain Youth Corps (RMYC) service-learning groups at our YRFRP planting sites where they helped remove invasive plants.

Internships

Recognizing the value of providing professional development training opportunities for young sustainability professionals, YVSC continues to build its internship program for college students and young professionals. Interns Loren Keen, Nicole Pepper, and Ryan Messinger supported the YRFRP through various field work opportunities including irrigation and leading RMYC crews. At the end of the year, YVSC began formalizing a more robust internship program with four additional interns coming on board.

Volunteer Opportunities

Despite limitations amidst the pandemic, YVSC was able to successfully engage volunteers across various Priority Areas, through the Organics Recycling Task Force, our annual ReTree planting event, the Fall Recycling Drop-Off, the CARbon-Free Challenge and through a partnership with the U.S. Forest Service to reseed areas of forest lost to wildfire.

Throughout the year and across programs, YVSC advocates for policies, decisions and actions that promote low-to-no carbon, resilient and sustainable futures in the Yampa Valley.

6. Expressing Change Through Art

YVSC contributed an educational display to a plein air exhibit at the Steamboat Art Museum alongside Yampatika. Plein air is an important medium for capturing a moment in time amidst changing climates and environments. YVSC presented images and related data on how the Yampa Valley is experiencing climate change and how you can join YVSC and our community in taking climate action.

7. Advocacy for Action

Through white papers, public comments, technical reviews of government planning documents and discussions, YVSC strives to bring relevant science, technology and policy research into the service of decision-making and sustainable action. Though YVSC does not endorse candidates, we are committed to increasing public understanding of issues and platforms that facilitate more sustainable futures and utilize our broad base of community supporters to rally for action. Advocacy for YVSC is nonpartisan, we are committed to pursuing decision making that simultaneously advances both environmental conservation and public health concerns.




How do we know climate change here in the Yampa Valley?





In March of 2020 the Governor of Colorado requested that all communities with a plastic bag ban temporarily rescind the ban and fee as part of COVID-19 efforts. During the midst of uncertainty regarding grocery bags as a potential vector for transmission, YVSC and community partners turned to relevant research to address the conflict as both an environmental and public health issue. With strong community support and research evidence suggesting that COVID-19 was no more likely to be transmitted by paper bags than plastic bags, YVSC submitted a white paper to City Council which recommended that Council follow the lead of surrounding mountain communities and retain the local plastic bag ban while waiving the bag fees on paper bags.

Community member interests joined with YVSC's recommendation and Council opted to retain the plastic ban bag and waive the bag fee on paper bags, thus attending to both public health and environmental concerns. This significant measure helped to maintain an 85% reduction in single-use plastic bags since 2019 and to sustain a consistent City position against single-use plastics. The estimated number of bags used during Oct. 2019-Oct. 2020 was 579,455. This is down from 3.8 million bags previously reported.




REDUCTION IN SINGLE-USE PLASTIC BAGS SINCE 2019




